#### Introduction

Lobbying in the City of New York is governed by Administrative Code §§ 3-211 through 3-223 and Chapter 1 of Title 51 of the Rules of the City of New York (collectively, the "Lobbying Law"). This is the nineteenth annual report issued by the Lobbying Bureau (the "Lobbying Bureau") of the Office of the City Clerk (the "City Clerk") pursuant to § 3-212(c) of the Administrative Code of the City of New York (the "Administrative Code"), the text of which follows:

The city clerk shall prepare and post on the internet an annual report relating to the administration and enforcement of the provisions of this subchapter. Such report shall contain information regarding (i) the number of complaints received from the public and the disposition of such complaints; (ii) the number and amount of civil penalties imposed pursuant to subdivisions (a), (b), (c) and (d) of section 3-223 of this subchapter; (iii) the number and duration of orders issued pursuant to subdivision (a) of section 3-223 of this subchapter; (iv) the number of random audits conducted by the city clerk and outcomes thereof; (v) compliance programs developed and implemented for lobbyists and clients; (vi) the types and number of requests for assistance related to the lobbying law received by the city clerk, and, as soon as practicable, the average response and resolution times of such requests; (vii) the number of lobbyists filing statements of registration pursuant to section 3-213 of this subchapter for the first time; (viii) the subject matter of lobbying activity most frequently reported by lobbyists; (ix) the lobbying targets most frequently reported by lobbyists; (x) the lobbyists that received the highest compensation; and (xi) such other information and analysis as the city clerk deems appropriate. Such report shall be posted on the internet no later than March first of each year and shall contain information relating to the preceding calendar year.

Listed hereafter is the information required by the Administrative Code for calendar year 2024.

# (i) Number of complaints received from the public and the disposition of such complaints.

In 2024, two complaints were closed. With respect to the first complaint, the City Clerk found no probable cause that Carlo A. Scissura violated Administrative Code §§ 3-213(a)(1), 3-

216(a)(1) or 3-217(a) *et seq*. With respect to the second complaint, the City Clerk found no probable cause that Joshua Mehlman violated such provisions of the Administrative Code.

Three new complaints were opened in 2024. As of February 28, 2025, they remain open.

## (ii) Number and amount of civil penalties imposed pursuant to subdivisions (a), (b), (c) and (d) of § 3-223 of the Administrative Code.

Violators of the Lobbying Law are subject to the penalties detailed in Administrative Code § 3-223 *et seq.* Pursuant to Administrative Code § 3-223(a), the penalties for knowing and willful violations of the Lobbying Law include: a civil penalty not to exceed \$30,000; the issuance of a cease and desist order; or both a civil penalty and a cease and desist order. Pursuant to Administrative Code § 3-223(b), violators are subject to a civil penalty not to exceed \$30,000 for violating a cease and desist order or for violating the proscription against contingency agreements. In addition to penalties for any late filing, pursuant to Administrative Code § 3-223(c), violators may be subject to a civil penalty, not to exceed \$20,000, if a violation is not cured. Lastly, for any violation of the Lobbying Law not covered in the foregoing provisions, pursuant to Administrative Code § 3-223(d), violators may be subject to a civil penalty not to exceed \$20,000 if a violation is not cured.

Listed below are the late filing and civil penalties<sup>1</sup> incurred for each reporting period as of February 28, 2025.

#### 2023 Reports (Sixth Periodic Reports and Client Annual Reports)

The Lobbying Bureau identified 39 Lobbyists<sup>2</sup> who failed to timely file an aggregate of 48 sixth periodic/annual reports<sup>3</sup> for 2023. For this failure, such Lobbyists incurred \$17,650 in aggregate late filing penalties. (See <u>Appendix A</u> attached hereto.)

The Lobbying Bureau identified 321 late client annual reports. For this failure, such clients incurred \$134,876.25 in aggregate late filing penalties. (See <u>Appendix B</u> attached hereto.)

No civil penalties were warranted for the late filing of the above-listed reports.

#### 2024 Statements of Registration and Periodic Reports

The Lobbying Bureau identified 92 Lobbyists who failed to timely file an aggregate of 163 statements of registration. For this failure, such Lobbyists incurred \$83,680 in aggregate late filing penalties. (See <u>Appendix C</u> attached hereto.)

One hundred and twenty-five Notices to Cure were sent to Lobbyists who failed to timely pay registration fees or submit retainer or amended retainer agreements. The Lobbyists cured such failures either by paying the fees or submitting the retainers.

The Lobbying Bureau identified 28 Lobbyists who failed to timely file an aggregate of 35 first periodic reports. For this failure, such Lobbyists incurred \$13,940 in aggregate late filing penalties. (See <u>Appendix D</u> attached hereto.)

The Lobbying Bureau identified 31 Lobbyists who failed to timely file an aggregate of 45 second periodic reports. For this failure, such Lobbyists incurred \$11,250 in aggregate late filing penalties. (See <u>Appendix E</u> attached hereto.)

The Lobbying Bureau identified 19 Lobbyists who failed to timely file an aggregate of 25 third periodic reports. For this failure, such Lobbyists incurred \$7,850 in aggregate late filing penalties. (See <u>Appendix F</u> attached hereto.)

The Lobbying Bureau identified 30 Lobbyists who failed to timely file an aggregate of 104 fourth periodic reports. For this failure, such Lobbyists incurred \$10,500 in aggregate late filing penalties. (See <u>Appendix G</u> attached hereto.)

The Lobbying Bureau identified 33 Lobbyists who failed to timely file an aggregate of 38 fifth periodic reports. For this failure, such Lobbyists incurred \$2,800 in aggregate late filing penalties. (See <u>Appendix H</u> attached hereto.)

No civil penalties were warranted for the late filing of the above-listed reports.

#### 2024 Fundraising and Political Consulting Reports

The Lobbying Bureau identified 4 Lobbyists who failed to timely file a total of 4 fundraising and political consulting reports. For this failure, such Lobbyists incurred \$1,750 in aggregate late filing penalties. (See <u>Appendix I</u> attached hereto.)

No civil penalties were warranted for the late filing of fundraising and political consulting reports.

#### 2024 Termination Notices

Eighty-nine Notices to Cure were sent to Lobbyists who failed to timely file termination notices. The filers cured such failures either by filing the missing termination notice or extending the lobbying contract. No civil penalties were warranted for missing termination notices.

## (iii) Number and duration of orders issued pursuant to subdivision (a) of § 3-223 of the Administrative Code.

None.

#### (iv) Number of random audits conducted by the city clerk and outcomes thereof.

The Lobbying Bureau selected 45 Lobbyists for audit in 2024. The 2024 audits encompassed an examination of all filings made in 2023 by the 45 randomly selected Lobbyists and associated clients to determine if such filings were complete, accurate, timely filed and otherwise in compliance with the Lobbying Law. The audits resulted in 63 findings and 63 required actions. Samples of audit findings included: reporting incorrect compensation and reimbursed expenses; reporting incorrect subject categories; failing to report all lobbying activity; failing to properly describe subject details; failing to report targets and contact names; reporting incorrect

targets; failing to report addresses of subject properties; inadvertently listing the names of children of lobbying employees in the statement of registration; failure to provide correct home addresses of employees lobbying for client; failure to include lobbyist and/or co-lobbyist in client annual reports; reporting inverted employee names; failure to include the compensation amount in the retainer; failure to upload the correct retainer agreement in the statement of registration; and failure to include the correct number of employees on a statement of registration or an authorization letter. Samples of required actions included: correcting compensation and reimbursed expense amounts; reporting correct subject categories; reporting all lobbying activity; amending reports to properly describe subject details; reporting targets and contact names; reporting correct targets; reporting subject addresses; removing the names of children of lobbying employees from the statement of registration; reporting the correct addresses of employees lobbying for the client; reporting lobbyist and/or co-lobbyist in the client annual report; correcting inverted employee names in the statement of registration; including compensation amount in the retainer; uploading correct retainer agreement in the statement of registration; and reporting the correct number of employees in a statement of registration or an authorization letter.

#### (v) Compliance programs developed and implemented for Lobbyists and clients.

The Lobbying Bureau works with filers<sup>4</sup> to improve compliance with the Lobbying Law in a variety of ways including training, outreach and other educational efforts. In addition, the Lobbying Bureau receives numerous telephone and e-mail inquiries throughout the year including: requesting assistance with filing reports; answering questions regarding requirements of the Lobbying Law; and providing technical assistance with e-Lobbyist. See (*vi*) *The types and number of requests for assistance related to the lobbying law received by the city clerk* for further information. Responding to these questions and requests for assistance continues to be an integral part of the Lobbying Bureau's daily functions.

#### Training

Pursuant to the Administrative Code, Lobbyists must complete mandatory training biennially. If a Lobbyist registers 30 or more clients and lists 5 or more lobbying officers or employees, then two officers or employees, one of whom must have lobbied in the prior year, must complete the training.

In 2024, in connection with the mandatory training program, the Lobbying Bureau conducted a total of 8 training sessions (3 lobbyist sessions and 5 lobbyist/client filer sessions) with approximately 265 attendees. Each session included a detailed overview of the requirements of the Lobbying Law and provided in-depth instructions on filing reports in e-Lobbyist. Sessions were held remotely via the Microsoft Teams platform. Eighty-six Lobbyists opted to fulfill the training requirement by viewing a pre-recorded video. In 2024, the Lobbying Bureau continued to ensure that first time filers were notified of the training requirement when lobbying activities commenced. New filers were emailed a training video and advised of the requirement upon their enrollment in the e-Lobbyist system. In addition, new clients were emailed an informational power point presentation detailing the Lobbying Law and its requirements.

Twenty-Four Notices to Cure were served in connection with the failure of Lobbyists to attend mandatory training. Twenty-three entities cured by completing training. Enforcement proceedings are pending against one entity.

#### **Outreach Efforts**

## <u>Notification to Recipients of Discretionary Funds under the City Council Fiscal Year</u> 2025 Adopted Expense Budget - Schedule C

The Lobbying Bureau sent approximately 1,863 emails to entities that received discretionary funding from the City Council for fiscal year 2025 but were not registered as New York City Lobbyists. Enclosed with the email was a summary of the Lobbying Law. The email alerted entities to the Lobbying Law and encouraged them to review their activities and related compensation and expenses to determine whether they were required to comply. The Lobbying Bureau received numerous telephone and email inquiries because of this outreach effort. In

addition, the Lobbying Bureau scheduled informational conference calls for entities which requested in-depth guidance and assistance.

#### Comparison of New York City and New York State Lobbying Reports

The Lobbying Bureau continued its efforts to uncover unreported City lobbying in 2024 by comparing 7,166 statements of registration filed with the New York State Commission on Ethics and Lobbying in Government ("COELG")<sup>5</sup> with statements of registration filed with the Lobbying Bureau as of August 13, 2024.

In total, 107 entities reported lobbying City targets with COELG but did not file a statement of registration with the Lobbying Bureau. Seventy-two were either below the threshold or already filing in e-Lobbyist. The Lobbying Bureau sent notices regarding thirty-five statements of registration. Thirty-one statements of registration were either amended to remove inadvertent targets or the related entity submitted affidavits affirming that they were not required to file statements of registration because: (1) the entity inadvertently listed a New York City target on the COELG statement of registration or retainer agreements when no City lobbying took place; or (2) the entity did not exceed the \$5,000 reporting threshold for City lobbying. Four statements of registration were filed and three entities received notices to cure due to late filing penalties.

#### **Other Compliance Efforts**

The Lobbying Bureau examines reports filed on e-Lobbyist to determine the accuracy of the information contained in the statements of registration, retainer agreements and periodic reports. In 2024, the Lobbying Bureau reviewed approximately 2,898 retainer agreements filed by lobbyists to ensure that the retainer agreements complied with the Lobbying Law.

#### **Retainer Issues**

All retainer agreements must contain: (1) the compensation payable to the lobbyist; (2) the client's name; (3) the terms of any third-party payments for the lobbyist's services; and (4) the duration of the term of representation, including the specific start date. *See Chapter 1 of Title 51*

of the Rules of the City of New York § 1-08. The Lobbying Bureau identified approximately 41 statements of registration which contained retainer issues including: (1) failure to include a full force and effect letter, (2) failure to upload the original retainer with the amended retainer, and (3) uploading the wrong retainer. Non-compliant lobbyists were contacted and required to correct the retainer issues within the cure period. No civil penalties were warranted for retainer issues.

#### Date Issues

In order to resolve date discrepancies, the Lobbying Bureau cross-checked start and end dates listed on the statements of registration with the corresponding retainer agreements contained in e-Lobbyist. The Lobbying Bureau identified approximately 47 statements of registration which contained issues with start and end dates in Lobbyists' filings by comparing the dates on the statements of registration with the dates listed on the related retainer agreements. Lobbyists were instructed to cure by amending either the date on the statement of registration or the date on the corresponding retainer agreement. Eleven Notices to Cure were served on Lobbyists. The Lobbyists cured the date issues, and no civil penalties were imposed.

#### Entity Name Issues

To resolve entity name discrepancies, the Lobbying Bureau cross-checked client names listed on the statements of registration and retainer agreements with the client enrollment name. The Lobbying Bureau identified 59 statements of registration which contained entity name issues. Notices to Cure were served on 6 Lobbyists. The Lobbyists were instructed to cure by: (1) filing an amended statement of registration with an amended retainer agreement listing the correct name; or (2) enrolling the new entity and filing reports under the new entity name. The Lobbyists cured the entity name issues and no civil penalties were imposed.

## (vi) The types and number of requests for assistance related to the lobbying law received by the city clerk.

In 2024, the Lobbying Bureau recorded its activities and the types and number of requests received.<sup>6</sup> From January 1, 2024 through December 31, 2024, the Lobbying Bureau's time was

allocated as follows: compliance 43%, enforcement 20%, audits 18%, investigations 9%, e-Lobbyist assistance 6%, and outreach/training 4% (see page <u>38</u>).<sup>7</sup> In addition, the Lobbying Bureau received approximately 917 telephone calls (see pages <u>39-41</u>) and 8,475 email requests (see pages <u>42-44</u>). The majority of telephone calls consisted of compliance inquiries. The majority of emails involved filers requesting assistance in completing an e-Lobbyist enrollment.

## (vii) The number of lobbyists filing statements of registration pursuant to § 3-213 of the Administrative Code for the first time.

In 2024, 48 Lobbyists filed statements of registration for the first time. This is a 9% decrease from the previous year. Twenty-two of these entities are lobbyists and 26 entities are lobbyist/client filers. The 26 lobbyist/client filers' industry categories were reported as follows: 5 banking & financial services; 5 public, community interest & not-for-profit organizations; 4 environment & natural resources; 3 real estate, construction, engineering & developers; 2 entertainment & sports; 2 labor; 2 technology, telecommunications & other media; 1 education; 1 manufacturing; and 1 tourism.

#### Number of Reporting Lobbyists and Clients

For calendar year 2024, approximately 634 Lobbyists filed statements of registration on behalf of 2,267 clients<sup>8</sup>. Such Lobbyists paid approximately \$208,100 in registration fees.

#### **Outlook For 2025**

In April 2024, the City Clerk was asked to testify before The New York City Council Committee on Governmental Operations, State & Federal Legislation which has jurisdiction over federal and state legislation (including Home Rule requests) and municipal governmental structure and organization. The City Clerk was asked to comment on pending legislation regarding post-employment restrictions on former elected officials and officers and employees of the City of New York pursuant to Chapter 68 of the New York City Administrative Code. In addition, the City Clerk provided testimony on all aspects of its operations including: staffing levels; the number of audits and investigations; the amount of late penalties imposed; knowing and willful violations; proactive investigations; its efforts to locate unregistered Lobbyists; and outreach and education for city employees and city policy makers. The City Clerk took special notice of the areas of inquiry and has plans to increase its initiatives to include the committee's recommendations in the upcoming year.

In 2025, the Lobbying Bureau will remain focused on compliance and enforcement of the Lobbying Law. The Lobbying Bureau intends to expand its education and outreach programs, specifically targeting elected officials and city agencies, and consequently broadening awareness of the Lobbying Laws and their application. In addition, the Lobbying Bureau plans to expand its protocol to review currently untapped sources of information that may assist the city clerk in identifying unreported lobbying.

The Lobbying Bureau will continue to: (1) fulfill its statutory mandates; (2) confirm the veracity of reports filed by Lobbyists and clients; (3) check information contained in the reports to verify the accuracy of the filings and resolve any discrepancies; (4) respond to requests for guidance and interpretations of the Lobbying Law; (5) conduct random audits; and (6) investigate

unreported lobbying. The Lobbying Bureau intends to focus additional efforts on staff training and development, increasing its outreach efforts and completing its pending advisory opinions.

In the upcoming year, the Lobbying Bureau will continue its efforts to collaborate with the NYC Office of Technology and Innovation ("OTI")<sup>9</sup>, and other city agencies, to develop and work towards implementing a new e-Lobbyist system.

The Lobbying Bureau, in conjunction with OTI, will continue to make information available via <u>NYC Lobbyist Search</u>, the public database of filings. The enhanced Lobbyist Search has enabled the Lobbying Bureau to further its mission of increasing transparency in government and allowed requests for information to be fulfilled more efficiently.

#### Analysis of Lobbying Data<sup>10</sup>

Each year the Lobbying Bureau analyzes the available data and reports on various macro and micro trends in City lobbying. In addition, the Lobbying Bureau receives many requests for information about City lobbying activity from the media and government watchdog organizations. In order to facilitate the transparency goals of the Lobbying Law, and in response to requests for information, lobbying data comparisons and analyses are included in the subsequent pages of this report. The data includes: top ten list of lobbyists based on compensation (see pages <u>12-18</u>); top lobbyists ranked by number of clients (see pages <u>19-21</u>); and top lobbyists ranked by number of employees (see page <u>30</u>).

The analyses of lobbyist/client filers includes top ten lobbyist/client filers ranked by compensation (see pages 22-25) and top lobbyist/client filers ranked by number of employees (see page 31). The analyses also contain information regarding clients including: top clients ranked by total compensation paid to all retained lobbying firms (see pages 26-27); top clients ranked by number of lobbying firms retained (see page 28); the top ten lobbying contracts (see page 29); and a breakdown of registered clients' industries (see pages 32-33). Also included are the top activities by subject category (see pages 34-35), top targets (see page 36) and an analysis of the data reported in the fundraising reports (see page 37).









### COMPARISON OF TOTAL CLIENTS OF TOP LOBBYISTS FROM 2021-2024\*





### TOP TEN LOBBYIST/CLIENT FILERS OF 2024 BY COMPENSATION




## <u>COMPARISON OF LOBBYIST/CLIENT FILERS' COMPENSATION</u> <u>FROM 2021-2024\*</u>





### **DISTRIBUTION OF CLIENTS' INDUSTRIES IN 2024**










# **DISTRIBUTION OF TELEPHONE INQUIRIES BY SUBJECT CATEGORY**






